The Slovak Anti-Doping Agency was established on 1 January 2009 pursuant to Section 6(1) of Act No. 300/2008 Coll. on the Organisation and Promotion of Sport.

Since 1 January 2016, it has been operating as a state contributory organisation established by Act No. 440/2015 Coll. on Sport, as amended.

The Ministry of Tourism and Sport of the Slovak Republic (abbreviation MTaS SR) is one of the 15 ministries of the Slovak Republic. The Ministry was established on 1 February 2024 by the amendment 7/2024 Coll. of the Act on Competence, adopted on 16 January 2024 during the fourth government of Robert Fico on the initiative of the Slovak National Party (SNS). The Ministry has taken over the tourism and sports agendas, which previously fell under the transport and education ministries.

As of 1 February 2024 SADA as a state contributory organisation came under the financial budget of Ministry of Tourism and Sport of the Slovak Republic.

SADA is an independent organisation which fulfils tasks in the field of prevention and control of doping in the territory of the Slovak Republic.

The position of the Slovak Anti-Doping Agency (SADA) is defined at the national level by two basic documents:

- Act No. 440/2015 Coll. on Sport and on Amendments and Additions to Certain Acts, as amended (hereinafter referred to as the "Sports Act"),
- SADA Statute issued by the Ministry of Education, Science, Research and Sport of the Slovak Republic pursuant to Section 86(6) of the Sports Act under No. 2016–9381/3493:1–56AA with effect from 1 February 2016.

On the basis of these documents, SADA is defined as a **legal entity** that acts in its own name in legal relations, acquires rights, undertakes obligations and bears responsibility for its actions.

The Act which came into effect on 1 January 2016 modified the status of the Agency – due to the need to increase the level of independence (in accordance with the requirements of the World Anti-Doping Code – WADC), SADA was transformed into a state contributory organisation established by law. As an independent institution, it fulfils the tasks of prevention and control of doping in the territory of the Slovak Republic.

At the same time, the personal scope of the Agency's authority has been modified in accordance with the rules of the World Anti-Doping Organisation (WADA). In addition to the legislative framework, SADA must also meet certain quality standards for its activities which are derived from its organisational structure – in particular from the organisational, working and registry regulations and plan.

In the area of doping control processes and the granting of therapeutic use exemptions, SADA is governed by a quality management system certificated according to the standard STN EN ISO 9001:2015.

SADA's mission and main objectives

The main objective of SADA is to fulfil the tasks set out in the Sports Act, in particular:

- Implementation of preventive measures in the fight against doping,
- cooperation with WADA, international anti-doping organisations and sports federations,
- coordination and execution of doping controls, especially in the field of elite and performance sport,
- the application of international treaties and conventions to which the Slovak Republic is a signatory,
- training and educational activities aimed at athletes and other target groups.

3. SADA'S ACTIVITIES IN 2024

- ASSESSMENT

The tasks of the Slovak Anti-Doping Agency (SADA) are set out in the Agency's basic documents as well as in the Contracts concluded with the Ministry of Education, Science, Research and Sport of the Slovak Republic and the Ministry of Tourism and Sport of the Slovak Republic for 2024.

3.1. OVERVIEW OF DOPING CONTROLS CARRIED OUT

SADA carried out doping controls in accordance with its obligations under the Contracts, the World Anti-Doping Code and the TDSSA Technical Document, which sets out the minimum number of additional analyses per sport and discipline. The main objective in 2024 was to maintain the proportion of out-of-competition testing at two-thirds of all collections. Priority was given to athletes from at-risk sports with potential participation in the 2024 Olympic and Paralympic Games in Paris.


In 2024, SADA carried out a total of **632 urine collections**, of which:

- 376 collections on behalf of SADA,
- **256 collections** on behalf of international sports federations.

Compared to 2023, SADA has seen:

- a 22.5% increase in urine collections at its own initiative,
- an 88% increase in urine collections ordered, mainly due to testing during the European Athletics U18 Championship in Banská Bystrica.

Types of testing (on behalf of SADA)

Urine collections carried out on behalf of SADA in 2024 were divided into out-of-competition and in-competition testing. In accordance with the distribution test plan, the Agency set a target ratio of 2:1 in favour of out-of-competition collections. This target was met - out-of-competition tests accounted for 68% of all collections, while in-competition tests accounted for 32%. With this, SADA continues its targeted strategy of focusing on out-of-competition testing as an effective tool in the fight against doping.

The set ratio of 2:1 (out-of-competition : in-competition) was met.




Fig. 2 Trend in the number of in-competition and out-of-competition controls carried out on behalf of SADA in 2019-2024.

Most frequently tested sports (on behalf of SADA)

In 2024, SADA focused on targeted testing in sports with a higher risk of doping and with athletes potentially participating in international events, including the Olympic and Paralympic Games in Paris. Out-of-competition controls were a priority, especially in individual endurance and power sports.

The table below lists the ten most commonly tested sports on behalf of SADA, including a breakdown of incompetition and out-of-competition urine collections.




Fig. 3 In-competition and out-of-competition controls on behalf of SADA by sport (2024).

Additional analyses

Additional analyses are conducted in accordance with the TDSSA (Technical Document for Sport Specific Analysis), which sets out the minimum number of specific tests for each sport and discipline. SADA is responsible for their implementation where it acts as the delegating organisation.

The following additional analyses were conducted in 2024:

- 99 ESA analyses testing for erythropoiesis-stimulating agents (e.g. EPO),
- 73 GHRF analyses testing for growth hormone and its release factors,
- 8 SPC analyses confirmation of steroid profile (conducted based on suspicion from the laboratory for substandard findings).

The SPC analysis is only exceptionally positive - in SADA's practice so far, only one such analysis has led to confirmation of the presence of a prohibited substance.

Blood draws and Athlete Biological Passport (ABP)

As part of its long-term strategy to improve the quality of anti-doping controls, SADA continued to perform blood draws in 2024, in particular for the purposes of creating and updating the haematology module of the Athlete Biological Passport (ABP).

In 2024, **62 blood draws for ABP** were performed on behalf of SADA, a decrease of 12 blood draws from 2023. This was mainly due to a reduction in the number of athletes included in long-term monitoring.




Fig. 4 Trend in the number of blood draws performed on behalf of SADA (2019–2024), by purpose of testing (ABP, GH).

Blood draws mandated by other authorities

In addition to its own activities, SADA also performed blood draws mandated by international sports federations and other organisations. In 2024 these were:

The following additional analyses were conducted in 2024:

- · 22 draws for ABP,
- 14 draws for growth hormone (GH).

Compared to the previous year, there was a slight increase in both types of draws. The draws were carried out mainly during important international events organized in the territory of the Slovak Republic.




Fig. 5 Trend in the number of blood draws mandated by other authorities (2019-2024).

3.2. ANTI-DOPING RULE VIOLATIONS

In 2024, SADA recorded eight new cases of possible anti-doping rule violations, with two additional cases carried over from 2023.

SADA handled 10 cases of possible anti-doping rule violations in 2024




Fig. 6 Structure of cases handled for possible anti-doping rule violations in 2024.

In four cases, anti-doping rule violations were proven, leading to the imposition of a sanction:

- three cases were related to the refusal of a doping control,
- one case concerned the presence of prohibited substances in a urine sample.

All four cases involved athletes competing in bodybuilding, specifically under the banner of the Slovak Association of Bodybuilding, Fitness and Powerlifting.

In terms of decision-making:

- in two cases, the decision was issued directly by SADA based on the athletes' timely admissions and their agreement to the sanction,
- in the other two cases, the Commission for Doping Proceedings acted as the body of first instance.

Trend in the number of anti-doping rule violations (2014–2024)




Fig. 7 Trend in the number of anti-doping rule violations (2014- 2024).

3.3. ADAMS

The ADAMS (Anti-Doping Administration and Management System) is an internet database system developed by the World Anti-Doping Agency (WADA). It is used to record, manage and exchange information relating to athletes, their whereabouts, doping controls carried out, therapeutic use exemptions (TUEs) and sanctions.

National Registered Testing Pool and the ADAMS

As of Q4 2017, new criteria for inclusion of athletes in the National Registered Testing Pool (NRTP) are in effect. SADA has progressively reduced the number of athletes included, based on WADA recommendations, with selection based on risk factors.

Each athlete included in the Register must undergo a minimum of three doping controls per year, which is another reason for narrowing the number of people monitored.

ADAMS statistics for 2024

At the end of 2024, 66 athletes were included in the Register, of which:

- 14 athletes in the National Registered Testing Pool (NRTP),
- 35 athletes in the Basic Register (BR),
- 17 athletes in the International Registered Testing Pool (IRTP).

The registered athletes come from 14 national sports associations, of which:

- 11 associations represent Summer Olympic sports,
- 3 associations represent Summer Olympic sports.

Warnings and unavailability for testing

In 2024, SADA issued 19 warnings for:

- failure to complete ADAMS data,
- or athlete unavailability for testing.

Due to the lower number of athletes in the NRTP, SADA was able to:

- carry out more out-of-competition controls per individual (min. 3 per year),
- and has also seen a decrease in warnings for failure to provide current whereabouts data.

SADA did not assess any warning for unavailability for testing as an anti-doping rule violation in 2024. In these cases, SADA asked the athletes for a written explanation and an update of the sports training schedule in ADAMS so that further testing could be carried out without jeopardising their sporting activity.




Fig. 8 Trend in the number of "Filing Failure" cases in 2017-2024.




Fig. 9 Trend in the number of "Missed Test" cases in 2017-2024.

3.4. GRANTING OF THEREPEUTIC USE EXEMPTIONS

In 2024, the Slovak Anti-Doping Agency (SADA) submitted a total of 7 Therapeutic Use Exemption (TUE) applications to the Therapeutic Use Exemptions (TUE) Committee for expert review.

The Committee considered individual cases in accordance with the requirements of **the International Standard for Therapeutic Use Exemptions**, which sets out the conditions for an athlete to be able to legally use a prohibited substance or method for medical reasons.

Out of a total of seven applications considered:

- 5 exemptions were approved,
- 2 applications were rejected most often due to insufficient justification of therapeutic need or the availability of alternative, authorised medicines.

The Therapeutic Use Exemptions (TUE) Committee considered 7 applications for therapeutic use exemption in 2024




Fig. 10 Results of the assessment of therapeutic use exemption applications in 2024.

3.5. EDUCATION

Lectures and direct educational activities

In 2024, SADA staff delivered a total of 51 lectures to approximately 3,000 participants, of which:

- · 35 face-to-face lectures,
- · 16 online lectures.

The target groups were athletes and their support staff, primary and secondary school and university students, doping commissioners, members of the Commission for Doping Proceedings and sports physicians. The lectures focused on the values of clean sport, nutritional supplements, doping control and prohibited substances, and were conducted in an interactive format.

There was a decrease of 22 lectures compared to 2023, mainly to less interest from schools.




Fig. 11 Forms of lectures delivered in 2023 and 2024




Fig. 11 Lectures by target group (2023 and 2024)




Fig. 12 Completion of online courses on the ADEL platform in 2023 and 2024

E-E-learning on the ADEL platform

Online education through the **ADEL platform (Anti-Doping Education and Learning platform)** remains a supporting element of the programme:

Course for international level athletes (EN version):

Since **April 2024**, a new course, Sport Values Online for Children (8-12 years old), has been launched, intended for primary school students, which they can also complete with the support of their parents or teachers.

New digital tools and databases

In May 2024, an updated database www.zakazanelatky.sk was launched, allowing athletes and experts to verify the antidoping status of all medicines registered in Slovakia (more than 54,000 preparations).

A press conference was held on this update (17 June 2024) with the participation of representatives of the Ministry of Tourism and Sport of the Slovak Republic and the National Sports Centre, and a promo video spot, available on YouTube, was also presented.

Podcasts (2024)

In 2024, new episodes of the SADA podcast were added, which dealt with current topics such as:

- Ecdysterone, brinzolamide eye drops, vitamin C

5. OVERVIEW OF REVENUE AND EXPENDITURE

Assessment of budgetary management in 2024

In 2024, the Slovak Anti-Doping Agency operated with a budget of **EUR 740,735**, which represents the total volume of revenue after adjustments and transfers from the previous period. Revenues came mainly from **source 111 (the main state budget)**, but **sources 46 and 131** also played a significant role, being used for specific tasks such as educational activities or ordered doping controls.

Basic facts for 2024:

- **Revenues from SOURCE 111** reached **EUR 622,394**, which is **103.4**% of the originally approved budget (EUR 602,394). One budgetary measure of EUR 20,000 for analyses, materials and commissioners' remuneration contributed to the increase.
- The balance of funds from SOURCE 131 was only EUR 14,049, which is a significant decrease compared to previous years, when more was drawn from this source.
- Revenue from other sources SOURCE 46 reached EUR 102,230, which represents 186% of the original budget (EUR 55,000). Of which:
 - **EUR 92,840** came from ordered doping controls,
 - EUR 1,680 came from the innovative educational programme "Antidoping in Practice",
 - the rest was income from professional lectures.
- Expenditures were spent efficiently, with all funds used as intended:
 - EUR 581,249 was spent from SOURCE 111,
 - EUR 14,049 was spent from SOURCE 131 (100% of the balance),
 - EUR 96,882 was spent from SOURCE 46, meaning that the Agency has a slight surplus until 2025.

In 2024, the Slovak Anti-Doping Agency operated efficiently and in accordance with the approved budget. Total revenue after adjustments and transfers reached EUR 740,735, which represents the highest budget volume in the last three years. The funds were spent effectively and evenly:

- SOURCE 111 was filled to 103.4%, mainly thanks to an additional budgetary measure,
- SOURCE 46 exceeded the planned volume by 86%, mainly thanks to income from ordered controls,
- all resources were used as intended and a slight balance remained until 2025.

Overall, the management for 2024 can be assessed as stable, transparent and financially balanced.
